SEN INFORMATION REPORT

At Kingston Park Academy we uphold children's right to education and recognise the diverse educational needs within our community. We believe we have a duty to offer that provision where we can, to foster inclusion and provide full educational access.

We will try to ensure that all barriers to equal access in our academy are removed or overcome. We monitor and track progress of all children so that the support provided is as effective as possible. We welcome the full engagement of parents and carers and where necessary seek support and advice from specialists outside school to ensure we develop and maintain a range of flexible resources to meet the needs of all our children.

SEN Link to Local Offer

The local authorities and other services must set out a Local Offer of all services available to support children who are disabled or who have special educational needs and their families. The local offer will enable families to understand what services they can access and what support they can expect from a range of local agencies, including from the local authority, health services, schools, leisure services and the voluntary sector. The kinds of special educational needs and disabilities that are provided for in school

Many children and young people have difficulties that fit clearly into one of these areas; some have needs that span two or more areas; for others the precise nature of their need may not be clear at the outset.

At Kingston Park Academy we aim to support all pupils with their learning journey and embrace an inclusive ethos.

Policies for identifying children and young people with SEND and assessing their needs

Arrangements for consulting parents of children with SEND and involving them in their child's education

If your child is identified as not making progress, the school will set up a meeting to discuss this with you and your child in more detail and to;

- Listen to any concerns you may have.
- Plan any additional support your child may need.
- Discuss with you any referrals to outside professionals to support your child.

Pupil and parent/carer voice is also vital part of target setting and the reviewing of progress of pupils who are supported with a SEND Support Plan or Education Health & Care Plan (EHCP).

Arrangements for consulting young people with SEND and involving them in their education

Pupil voice is paramount in the development of support plans and meeting children's needs to address their barriers to learning. One Page Profiles are created with children which focus around 3 key areas:

- Facts about me
- Getting to know me
- What works well with me

Children's responses are listened to and included in Graduated Approach SEND and Individual support plans; playing a primary role in developing key outcomes and short term targets.

Arrangements for assessing and reviewing children and young people's progress towards outcomes, including the opportunities available to work with parents and young people as part of this assessment and review

Your child's progress will be continually monitored by his/her class teacher. His/her progress will be reviewed three times a year in reading, writing and maths.

At the end of year 6, all children are required to be formally assessed. This is something the government requires all schools to do and the results are published nationally.

Where necessary, children will have a Graduated Approach SEND Support Plan with targets set that are designed to accelerate learning and close the gap. Progress against these targets will be reviewed regularly (minimum termly), evidence for judgments assessed and a future plan made. This will follow an 'Assess, Plan, Do, Review' model. This process will take place with the pupil and parent/carer voice included.

The progress of children with a statement of an EHC Plan will be formally reviewed at an Annual Review with all adults involved with the child's education. This process will take place with the pupil and parent/carer voice included.

The SENCo will also check that your child is making good progress within any individual work and in any group that they take part in.

Regular book looks and learning walks will be carried out by the SENCo and other members of the Senior Management Team will take place to ensure that the needs of all children are met and that the quality of teaching and learning is high.

Arrangements for supporting children and young people in moving between phases of education and in preparing for adulthood. As young people prepare for adulthood outcomes should reflect their ambitions, which could include higher education, employment, independent living and participation in society

We recognise that transitions can be difficult for a child with SEND, and we take steps to ensure that any transition is as smooth as possible.

If your child is joining us from another school:

- The SENCo will attend Annual Reviews when appropriate and invited.
- Your child will be able to visit our school and stay for early transition sessions, if appropriate.
- Your child and parents/carers will have the opportunity to view the school and meet some of the staff.
- Your child will be asked to complete a 'one page profile' to help support them as they move into our school.
- Information about your child will be requested.

If your child is moving to another school:

- We will contact the school SENCo and ensure he/she knows about any special arrangements or support that need to be made for your child. Where possible, a planning meeting will take place with the SENCo from the new school.
- We will make sure that all records about your child are passed on as soon as possible.
- Your child's 'one page profile' will be passed on to help support them when they move on.

When moving classes in school:

- Information will be passed on to the new class teacher in advance and in most cases a planning meeting will take place with the new teacher. Graduated Approach SEND Support Plans will be shared with the new teacher.
- Pupils will have the opportunity to be taught by their new teacher in their new class before the end of the previous year.
- Additional transitional visits will also be arranged if needed.
- Your child's 'one page profile' will be passed on to the new teacher to help support them in their new class.

In Year 6:

- The SENCo and/or year 6 teachers will discuss the specific needs of your child with the liaison teachers from your child's secondary school.
- We will make sure that all records about your child are passed on as soon as possible.
- If your child has an EHC Plan, the SENCo from your child's next school will be invited to the year 5 and year 6 Annual Review meetings.
- Your child will participate in focused learning relating to aspects of transition, to support their understanding of the changes ahead.
- Where possible, your child will visit their new school on several occasions, and in some cases staff from the new school will visit your child in this school.

Approach to teaching children and young people with SEND

Excellent targeted classroom teaching, also known as Quality First Teaching, is the first wave of support Kingston Park provides for all children. All teaching is based on building on what your child already knows, can do and can understand.

Different ways of teaching, as well as a wide range of interactive resources, are available and in place so that your child is fully involved in their learning to help improve accessibility.

At times the teacher may direct the class based Teaching Assistant to work with your child as part of normal working practice.

Specific strategies (which may be suggested by the Inclusion Manager or external agencies or providers) are in place to support your child to learn.

Teachers will closely monitor your child's progress monthly and will be proactive in monitoring any gaps a child may have in their understanding/learning and if they need some extra support to help them make the best possible progress.

How adaptations are made to the curriculum and the learning environment of children and young people with SEND; schools should include details of how the broad and balanced curriculum is adapted or made accessible for pupils with SEND

Class teachers plan lessons according to the specific needs of all groups of children in their class and will ensure that your child's needs are met through a variety of means;

- Teaching Assistants, under the direction of the class teacher, can adapt planning to support the needs of your child where necessary.
- Specific resources and strategies will be used to support your child individually and in groups.
Adapted resources e.g. practical resources, displays, table top reminders, visual timetables.
- Planning and teaching will be adapted, on a daily basis if needed, to meet your child's learning needs.
- Support from Outside Agencies (direct working and advice for staff)
- Break time support e.g. Lunchtime Support, TA Support.
- Support for parents through the CAF (Common Assessment Framework) as needed.
- Home-school liaison and differentiated homework tasks
- Additional sessions such as Anger/Behaviour Management groups, Physiotherapy activities, Handwriting and motor skills sessions.
- A range of extra-curricular activities and clubs to enhance a variety of skills (sport, art, ICT, social skills, maths, English)

The expertise and training of staff to support children and young people with SEND, including how specialist expertise will be secured

The SENCO's job is to support the class teacher in planning for children with SEND. The school provides training and support to enable all staff to improve the teaching and learning of children, including those with SEND. This includes whole school training on SEND issues, such as Autism Spectrum Disorder (ASD), dyslexia and speech and language difficulties.

Regular TA meetings are also used by the school to disseminate information and train the support staff.

Individual teachers and support staff attend training courses run by outside agencies that are relevant to the needs of specific children in their class, e.g. Autism, Speech & Language, Phonics, Rainbows, Guided Group Work, First Aid, Specific Medical Needs, Positive Handling, and Attachment.

Evaluating the effectiveness of the provision made for children and young people with SEND

The school budget, includes money for supporting children with SEN. The Headteacher decides on the deployment of resources for Special Educational Needs and Disabilities, in consultation with the school governors, the SENCo and the Senior Management Team on the basis of needs in the school.

The SENCo and the Senior Management Team discuss all the information they have about SEND in the school, including;

- the children getting extra support already,
- the children needing extra support,
- the children who have been identified as not making as much progress as would be expected.

From this information, they decide what resources/training and support is needed. The school also identifies the needs of vulnerable pupils on a provision map. This identifies all support given within school and is reviewed regularly and changes made as needed, so that the needs of children are met, and resources are deployed as effectively as possible.

How children and young people with SEND are enabled to engage in activities available with children and young people in the school who do not have SEND

Kingston Park Academy strives to achieve participation for all and achievement for all by creating an inclusive 'can do' attitude among our pupils. We value high quality teaching and learning and, as such, each pupil within the school is formally monitored as part of a review process at least three times per year.

The majority of learners with SEND are differentiated for by subject teachers adapting the curriculum as set out in the Teachers' Standards 2012. More information is available on these at <https://www.gov.uk/government/publications/teachers-standards>

Support for improving emotional and social development. This should include extra pastoral support arrangements for listening to the views of children and young people with SEND and measures to prevent bullying

We recognise that some children have extra emotional and social needs that need to be developed and nurtured. These needs can manifest themselves in a number of ways, including behavioural difficulties, anxiousness, and being uncommunicative.

All classes follow a structured curriculum which includes modules focused on PHSCE to support this development. However, for those children who find aspects of this difficult we offer;

- An in-school nurture provision called Thrive for pupils who have suffered a bereavement in the family or some kind of loss (inc.divorce). This programme is run by our Pastoral Support Lead.
- Lunchtime and playtime support including playleader led activities.
- Social groups that can focus on a variety of different social and emotional needs depending on the need.
- Thrive.

If your child still needs extra support, with your permission the Pastoral Support Lead will access further support through the CAF process.

How the school involves other bodies, including health and social care bodies, local authority support services and voluntary sector organisations, in meeting children and young people's SEND and supporting their families

At Kingston Park Academy, we embrace additional support from external agencies in order to assist the school in meeting the needs of children and their families. Outside agencies such as the Educational Psychology Team, Cognition and Learning Team and SFSS (Schools and Family Support Services) are contacted where appropriate for specific students, based on their area of need.

What is the Local Offer?
